**O R D E R**

The above named complainant, a person with 55% locomotor disability filed a complaint dated nil received in this office on 14.11.2013 under the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, hereinafter referred to as the Act regarding personal loan.

2. The complainant submitted that his salary was being debited in the Canara Bank Account No. 1861101004419. He was in need of some loan and the bank was ready to give the loan amount but his office was not sanctioning the loan form.

3. The matter was taken up with the respondent vide letter dated 07.02.2014 followed by reminder dated 25.04.2014.

4. The complainant vide letter dated 10.04.2014 submitted that he had not received any reply from the respondent till date.

5. Upon considering the reply dated 10.04.2014 of the complainant, a hearing was scheduled on 10.07.2014.

During the hearing 10.07.2014, the Registrar, Central Institute of Hindi, Agra submitted that action on the direction of this Court had already been taken on 05.05.2014 vide their letter No. 799 dated 05.05.2014. Thereafter, the Guwahati Centre of Central Hindi Institute vide letter No. 2-50(Guwa.)/2013-14/123 dated 13.06.2014 had also informed this Court that the loan application of the complainant had already been sanctioned and the signature had been put on that. In view of the positive action by the respondent, the case is disposed of without any further directions.
