ACTIVITY REPORT

1st April 2024—31st March 2025

It is a matter of immense joy for us to present the Activity Report of All India Confederation of the Blind you the period 1st April 2024—31st March 2025. During this period, the Organization has successfully carried forward all its projects as well as set course towards some new initiatives. All the office bearers have contributed to this endeavor to the best of their capacities, resulting in enhanced recognition and visibility of our Confederation. Some of the salient glimpses of our work are detailed below:

1. AWARDS AND REPRESENTATIONS

Our President Professor Anil K. Aneja was conferred the 2nd International Mata Savitribai Phule Award by Antarrashtriya Mata Savitribai Phule Shodh Sansthan on January, 2025. He also presented and chaired sessions in a number of conferences relating to disability. These included making a presentation and chairing a session at the ICEVI World Conference in Ahmedabad as well as an invited presentation at the India Inclusion Summit in Bengaluru.

Our Vice-President Ms. Muthu Selvi received the Role Model Award from the Lotus Blind Welfare Trust of India in March, 2025. She was also invited to make a number of presentations which included the following:

- "From Stigma to Strength: Overcoming Challenges of Visually Impaired Women" at Soka Ekita College on December 10, 2024.
- Lectures on sex education programs for visually impaired school girls on February 7, 2025, and for visually impaired college girls on February 9, 2025. These lectures were conducted in Chennai by Miss Pauline from London.
- Acted as a resource person for a program on disability and sanitation conducted by Kriya on February 11, 2025.
- Lecture on "Challenges of Visually Impaired Women in India" at the Central University of Tamil Nadu, Thiruvarur, on February 25, 2025.



Professor Aneja, along with our Secretary Ms. Manjula Rath, participated in a week-long workshop on capacity building organized by the Danish Association of the Blind in December 2024.

2. EDUCATION

AICB's Captain Chandan Lal Special School for the Blind, Gurugram, has been actively engaged in various events and activities throughout the period under report, fostering holistic development and community engagement. During the year 2024-25, 120 visually impaired children received education in the school, and 11 students cleared class 8th and passed out of the school. In the period under report, some of the school activities were sponsored by Mitsubishi Electric Automotive India Pvt. Ltd. (MEAI). The company has been supporting the salary of the teaching staff, hostel, repairs, and other maintenance expenses consecutively for the fifth year. MEAI provided support to the tune of Rs. 56,32,162 for the financial year 2024-25 and also committed a sum of Rs 55,00,000 for the financial year 2025-26. This clearly demonstrates their trust and confidence in the work done by our Organization. Further, the school has also received support from many other organizations and individuals in various ways for which we extend our deep appreciation. These include:

- Mrs. Madhu Soota has provided a sum of Rs. 2,50,000 for setting up a gym in memory of her late husband Mr. Ved Prakash Soota.
- Monetary support of Rs. 3,500 per month for three students since August 2024 by Preferred Square Company.
- GSPANN Technologies Pvt. Ltd has donated Rs. 5,15,000 for Braille books and Braille appliances.
- Fluor Daniel India Pvt. Ltd. has provided 120 packets of Braille papers, 45 Braille slates, and many Braille books.
- Donation of 120 sets of tactile diagrams books by Raised Lines Foundation.
- Organization of two health check-up camps by HCW Foundation and FCW Foundation respectively.

Students and teachers from some renowned schools and colleges such as Scottish High International School, Lord Jesus Public School, Vega School, CCA School Gurugram, DPG B.E.D College, DPG Polytechnic, Rao Lal Singh College of Education, etc. visited our school. Representatives of a number of corporates such as M.G. Motors, Mitsubishi Electric Automotive India Pvt. Ltd, Preferred Square, Analytics, Bank of Baroda, SAYS Community Chennai, B.M. Tear ARGL Pvt. Ltd., JTEKT Micromatic Pvt Ltd, Fluor Daniel India Pvt. Ltd., etc. also took a keen interest in our activities during their visits to the school.

Important occasions such as Independence Day, Teachers' Day, Dusshera, Deepawali, Christmas, Republic Day, Shivratri, Holi, etc. were celebrated in the school. The students also took part in various competitions and won 20 prizes, including 6 first prizes.



3. BRAILLE PRESS

During the period under report, AICB Braille Press has produced 25,91,050 Braille pages consisting of 1,38,273 volumes. It has also produced 135 new titles, out of which 29 were sponsored by the Rotary Club of Shahdara and 2 were sponsored by Saksham Bharti and Saksham Rozgar Society. The Confederation has also maintained the publication of the following magazines in Braille:

4. TRAINING AND EMPLOYMENT

AICB runs three training courses oriented towards the development of employment skills—Advanced Diploma in Computer to prepare visually impaired persons for jobs in Government and Private Sectors; year-long Stenography and Computer Training; and a basic three-month training in Computer Applications. These courses were financially supported by the WIPRO Foundation which sponsored 20 computers in addition to the staff salaries during this period.

(a) Advanced Computer Training: 11 trainees (5 Male and 6 Female) were enrolled in the computer training programme from April to July 2024. The final examinations were held on 26th July, 2024 for the outgoing batch. NIIT Foundation was engaged in the annual evaluation of trainees. Out of the 11 appearing candidates, 5 students were declared as ‘Outstanding’ (90-100%) and the other 6 students secured the rank of ‘Excellent’ (80-89%).

Written tests and interviews were conducted on 31st July, 2024 for admission to the next batch of computer training. A total of 23 applicants appeared for the test, out of which 11 got selected.

(b) Hindi Stenography: Examinations for 14 trainees were conducted from 26th July – 28th July, 2024 in which all of them qualified. On 31st July, 2024, skill tests and interviews were held for the recruitment of the new batch for the year 2024-2025. 50 candidates appeared for the test, out of which 15 got selected. The course for the newly admitted students started from 1st August, 2024.

(c) Basic Computer Course: In addition to the above, AICB continues to provide 3-4 months training in basic computer skills. 55 V.I. persons (15 Male, 40 Female) completed their basic computer training during the period under report. This number also includes trainees of the Intensive Training course which was held during the months of June and July 2024.



5. WOMEN EMPOWERMENT

AICB envisions to socially, economically, and culturally empower women to create an equitable society, enabling them to make their own decisions, access resources, participate fully in all aspects of life, and firmly stand against any form of discrimination and oppression.

(a) Hostel Facility for Visually Impaired Girls

Our Organization operates a dedicated hostel facility providing a supportive and inclusive environment for around 60 visually impaired girls pursuing higher education and vocational training. This hostel facility empowers these girls to achieve their educational and vocational goals, fostering independence, confidence, and self-reliance.

(b) Intensive Training Course for Blind Women

With generous support from IO Tech World Avigation Pvt. Ltd., our Confederation conducted an Intensive Training program for 29 visually impaired women from Chhattisgarh, Delhi, Gujarat, Haryana, Maharashtra, Punjab, Rajasthan, Uttar Pradesh, and Uttarakhand.

Program Details:

- Duration: June 10th - July 16th, 2024
- Skills Covered:
 - Orientation and Mobility
 - Cooking and Home Management
 - Computer literacy
 - Self-defense techniques

Additional Enrichment Sessions:

- Weekend lectures on:
 - Personality Development and Soft Skills
 - Organizational Structure and Management
 - Infant and Child Care
 - Team Management and Leadership
 - Career Opportunities for Visually Impaired Women



- Gender Issues and Women’s Empowerment
- Disability and Law
- Personal Health and Hygiene
- Reproductive Health and Sex Education

At the end of the training course, examinations were conducted on the basis of which 4 outstanding trainees received laptops and certificates for exemplary performance. The closing ceremony was graced by Dr. Kavita Bhardwaj, Sr. Engineer, IO Tech World Avigation Pvt. Ltd. & Associate Professor, NSUT. Mr. Jai Dutt Bhardwaj, Retd. Engineer (PWD), Haryana was the Special Guest.

(c) Celebration of International Women’s Day

Like previous years, this year also the International Women’s Day was celebrated with great enthusiasm in the premises of AICB on 8th March, 2025. Among others, girl students residing in AICB hostel, and some former trainees participated in the event. Mr. Kulwant Rana, MLA, Rithala Constituency, graced the occasion as the Chief Guest. The speakers included Ms. Manjula Rath (Secretary, AICB) and Dr. Sadhna Arya. A non-filmy singing competition was organized and prizes were given away to the winners.

Also, on 22nd March 2025, a workshop on reproductive healthcare and rights for visually impaired women was held in Chennai which was attended by 37 participants, and co-ordinated by our Vice-President Ms. Muthu Selvi. She also delivered a talk on the occasion of the International Women’s Day at an event organized by the Tamil Nadu Association for the Blind. Ms. Muthu Selvi also delivered another talk to mark the International Women’s Day at a function organized by the Visually Impaired Women’s Association in Chennai on March 9th, 2025.

6. ADVOCACY

Continuing our endeavors towards non-discrimination and empowerment of the visually impaired through advocacy initiatives, the Confederation has taken the following significant initiatives:

- a) Pursuing the earlier court cases,
- b) Filing fresh petitions,
- c) Making representations to the Government, and
- d) Helping various individuals in solving their rights-based issues.

A number of cases have continued to be pursued and success in some cases has been achieved.



- i. A case was filed in Telangana High Court by our affiliate DWAB with support from AICB, seeking the appointment of an independent Commissioner for Disabilities there. The high court ordered in favor of our petition and this success was widely covered in the media in that state.
- ii. We also got a positive order from the Delhi High Court in our case taking the equivalence of special B.Ed. with B.Ed. for appointment in schools. This case was filed some years ago. While recently disposing of this case, the Delhi High Court directed the concerned department to consider our petition as representation and decide upon it with reasons in four weeks' time. In case we are not satisfied with the response of the department, we can approach the Center Administrative Tribunal.
- iii. In Uttar Pradesh, responding to our case in the Lucknow Bench of Allahabad High Court regarding incorrect, improper, and inadequate identification of posts for the visually impaired, the UP govt. has amended its earlier notification, identifying a number of posts for blind and low vision.
- iv. Challenging an advertisement for nearly 2000 vacancies for the post of Assistant Professor as there were gross violations of reservation for Persons with Benchmark Disabilities in the said advertisement. It is at the stage of the final hearing.
- v. In respect to our case against Dr. Shakuntala Misra National Rehabilitation University, challenging two advertisements on the ground of not providing reservation to the visually impaired, a notice has been issued to the concerned University.
- vi. Our two other cases filed in UP, namely the denial of use of scribes by visually impaired candidates while taking examinations for various clerical posts advertised and the opening up of the post of Deputy Commissioner, Disabilities, earlier reserved for the visually impaired, for all disabilities, are also being pursued.
- vii. Our case in the Delhi High Court pertaining to the identification of currency notes and coins is at the advanced stage of hearing. Our case against Punjab and Sind Bank for not providing reservation in promotion is also being pursued.
- viii. A Representation has been sent to the concerned ministries/departments regarding providing GST concessions to visually impaired persons on vehicles purchased by them. A PIL is due to be filed. Similarly, a PIL has been prepared to be filed in Allahabad High Court on the issue of difficulties being faced by persons with blindness and low vision in public transportation for their daily commute due to the absence of accessibility features in the UPSRTC Buses, safe pedestrian sidewalks, availability of sufficient accessible transport options, etc.
- ix. Individual guidance has continued to be provided to visually impaired persons and affiliates regarding their rights-based issues.

7. CRISIS INTERVENTION UNIT

The Crisis Intervention Unit provides critical support to individuals who lose their eyesight at a later stage in life,



empowering them to adapt and lead independent lives. The comprehensive training program includes orientation and mobility, Braille reading and writing, daily living skills, cooking and household management, and computer training. During the reporting period, 27 newly blinded persons (16 male, 11 female) received training.

8. YOUTH EMPOWERMENT SCHOLARSHIP

AICB Saksham Bharti and Saksham Rozgar Society Scholarship Program:

Our organization is proud to support the educational and personal growth of visually impaired youth through the Saksham Bharti and Saksham Rozgar Society Scholarship Program. A total of 19 beneficiaries were given scholarships of Rs. 1000 per month per person with a total amount of Rs. 1,85,000.

9. COMMUNITY-BASED REHABILITATION PROGRAMME FOR RURAL BLIND PERSONS

AICB runs two Community-based rehabilitation programmes in Jalaun and Pratapgarh (Uttar Pradesh) respectively. During the period under report, a total of 151 visually impaired individuals (75 in Jalaun and 76 in Pratapgarh) received training, out of which 40 persons (Male-28, Female-12) in Jalaun and 41 (Male-26, Female-15) in Pratapgarh were rehabilitated in vocations such as petty shops, animal husbandry and agriculture with a grant of Rs. 15,000 each. With a view towards sensitizing the community, 2 family counselling meetings, 4 advocacy meetings, 4 awareness camps, and meetings with 2 Govt. officials were held. Further, as many as 26 meetings of chapters, 20 in Jalaun and 6 in Pratapgarh were held. Through the govt. schemes following benefits were provided:

- 21 persons supported through PM Awas Yojna
- Govt. pension of Rs. 1000 per month arranged for 42 persons (M-28, F-14)
- UDID cards for 85 persons (M-50, F-35)
- Bank loans amounting to Rs. 1,50,000 for 3 persons
- Street vendor loans amounting to Rs. 10,000 each for 4 persons
- 5 children helped with school admissions.

We are happy to report that DAB has committed a four-year support to AICB under its RISE (Rights, Inclusion, Strengthening, Empowerment) programme from 2025-2028. The inception phase of this programme was undertaken from January-April 2025 which involved reconnecting with the earlier beneficiaries on an individualized basis to ascertain their present status and the extent of the success of the programme. For this purpose, activities to be undertaken during this four-month period were identified and data collection tools were prepared. The CBR committee played an advisory role after the first month of the inception phase and regular meetings were held with the DAB programme manager. The data collected from 664 beneficiaries was digitized and analyzed.



We have satisfaction in reporting that due to the hard work of all concerned in the implementation of the DAB project from 2019 onwards, more than 80 percent of the beneficiaries have continued their vocational activities and nearly 10 percent have moved on to other vocations. Around 10 percent of those who have received grants from AICB under the DAB project have been unable to continue their vocations due to various reasons.

The above exercise has proved to be very useful, not just in reconnecting with the beneficiaries, but also learning lessons from our past work. These have been used in planning and preparing the project documents for the next four years.

As a part of capacity building, a one-week training was organized for CBR staff at AICB Headquarters from April 15th - 21st. During this workshop, among others, Head, International Programme, DAB, Mr. Thomas Skielboe interacted with the participants. A tripartite interaction involving the CBR staff, two AICB affiliates, and AICB office bearers also took place.

The above highlights demonstrate AICB's commitment to empower the visually impaired communities living in the rural areas in both Jalaun and Pratapgarh through CBR initiatives.

10. CELEBRATION OF LOUIS BRAILLE DAY

Louis Braille's 216th birthday was celebrated as Braille Day with great fanfare by AICB. On this occasion, many competitions and events were organized. The 21st Braille Reading and Writing Competitions were held on 3rd January, 2025 in which 71 visually impaired students of 24 schools from 11 states of the country participated. For the Madanlal Khandelwal Memorial Braille Essay Competition, we received 37 entries in the Junior Group and 17 in the Senior Group in both Hindi and English.

On the same day, the Sham-e-Ghazal programme was organized at 2:00 pm, in which 9 visually impaired artists presented their ghazals to enthrall the audience. A Kavi Sammelan was organized at 5 pm, in which about 10 famous poets of different rasaas (emotions) mesmerized the listeners by presenting their poems on various themes.

A grand function was organized on 4th January, 2025 in the premises of AICB, which was graced by Dr. S.K. Prasad, the former Deputy Chief Commissioner for Disabilities as the Chief Guest and Professor Sanjiv Tiwari, Principal, Maharaja Agrasen College, University of Delhi, as the guest of honour. The award winners were honored in this function with cash and other prizes amounting to Rs. 2,59,000/-. In particular, we would like to mention that Ms. Ayushi was conferred the Krishnawanti and Manoharlal Memorial Award of Rs. 51,000/- for her impressive performance in the Civil Services Examination and Ms. Ponnu M. received the Krishna Kumari Varma Memorial Award of Rs. 40,000/- for securing first rank in Master's (Women's Studies) of Mother Teresa Women's University, Tamilnadu. The main attractions of the cultural program were dance performances and songs, particularly by our school children. The program was attended by about 500 persons.



11. PENSION TO THE ELDERLY BLIND

We remain committed to supporting elderly blind individuals, ensuring their dignity and well-being. During the period under report, financial assistance of Rs. 6000 per person with a total amount of Rs. 2,94,000 to 49 elderly blind was provided.

12. RESOURCE GENERATION

It is a well-known fact that AICB began with very meager financial resources of around Rs. 300, but due to the sustained efforts and hard work of our Secretary General, today our resources are nearly 4 crores per year. To further enhance the activities of the organization and in view of the withdrawal of grants by certain foreign organizations, it was felt that we should make more concerted efforts towards fundraising. As our Secretary General has not been well, our Secretary Ms. Manjula Rath took on this responsibility in July 2024 and later a fundraising committee was formed under the chairmanship of our Treasurer Mr. Satish Chand Sharma. The members of this committee as well as others have worked hard which is seen in the fact that around Rs 28,00,000 have been raised through the above initiative. An MOU has been signed for Rs 81,00,000 for the purchase of one Braille embosser. Work and discussions on some other projects are also underway.

Owing to the hard work of the office and the school staff, there has been an increase of Rs. 34,07,177 in the non-corporate donations in the AICB office and schools during the financial year 2024-25 in comparison to the financial year 2023-24 which marks an increase of nearly 24% in the non-corporate donations.

13. SUPPORT TO AFFILIATES

A sum of Rs. 9,60,000 was provided to 11 affiliates by way of supporting various projects submitted by them. The names of the affiliates along with project details are:

- i. BPA, Mumbai: Salary of an advocacy officer for six months.
- ii. CSGAB: One day seminar on advocacy for first year college students and for filing one PIL.
- iii. Drishti: One awareness workshop for blind women.
- iv. DWAB: For filing a case challenging non-reservation for persons with disabilities in allotment of shops in Telangana.
- v. Mizoram Blind Society: Translation of basic and diploma computer study material in Mizo language.
- vi. Navchetan Andhjan Mandal, Gujarat: Two Skill development workshops on access technology for blind women.



- vii. RNKS: To establish a resource room for V.I. individuals.
- viii. NAVH, Lucknow: Salary of an advocacy officer for six months.
- ix. Akhil Gujarat Andh Shikshak Sangh: 3-day workshop on inclusive smart class technology.
- x. OAB: Salary of placement officer for six months.
- xi. TAB: Salary of computer instructor for six months.
